Business manager visa applications are reviewed on an individual basis. The following conditions and guidelines are merely guidelines. If you would like a specific consultation, please contact us.



Main requirements for business manager visa

 \Box Be the sole representative of a joint stock company (LLC) (joint representatives are not permitted)

 \Box Capital of 5 million yen or more

 \Box A separate space for administrative work (if within a store, it must be clearly separated from the treatment space)

- □ Sales forecast is at least 8 million yen (guideline)
- □ Be enrolled in social insurance (or plan to be enrolled)
- \Box There are staff members (cooking staff) who will be employed for treatment (resident's card, etc. is required)

<If you are running a restaurant>

- □ Have a restaurant business license
- \Box As a guideline, there should be more than 30 seats

Expected examination points

• Explanation of the individual's management capabilities and supporting documents

If you have management experience overseas, submit the management company's registry, financial statements, website, etc.

• How feasible is the business plan? (Assessed from the business plan)

-Do you have or plan to have a contract with a tax accountant?

-If you have no management experience, do you have a management advisor?

Procedure

1. Decide on a location for your store

2. Transfer capital (from the person himself/herself to a collaborator living in Japan, etc.)

3. Company establishment (if a company is acquired, registration of changes to officers, head office address, etc.)

4. Preparation of necessary documents for business manager visa

• The specific documents required will vary depending on the case.

• Usually, most documents can be prepared and arranged by the administrative scrivener

5. The application and examination period for a business manager visa at the Immigration Bureau

will depend on the circumstances (personal background, company size, business plan feasibility, administrative circumstances, etc.)

6. Obtaining a Business Manager Visa

Documents required for business manager visa application (example)

The documents required will vary depending on the situation, but the following documents will be required:

Documents relating to the individual

- \Box ID photo (taken within the last 3 months, 40 x 30 mm)
- □ Copy of passport (photo page, Japan entry/exit stamp page)
- □ Resume
- \Box Deposit certificate

Only if you have the following:

- □ University graduation certificate (copy)
- □ Documents proving Japanese language proficiency
- □ Certificate of registered matters of the company you were running (copy)
- □ Financial statements, tax payment certificates, etc. of companies you have operated

(for the past year)

 $\hfill\square$ Awards and certificates, photos, etc.

Company Documents

 \Box Business plan

 \Box Copy of the building lease agreement

Copies of documents submitted to the tax office

 \Box Copy of the notification of opening of a payroll office, etc. (with the tax office's acceptance stamp)

 \Box Copy of application for approval of special payment deadline for withholding income tax (with tax office stamp)

□ <u>When acquiring an existing company</u>

 $\hfill\square$ Latest fiscal year balance sheet and income statement

FAQ

How long does it take to process a Business Manager Visa application?

 \rightarrow It depends on the size of the company, the number of employees, the individual's background, etc., but it usually takes 3 to 5 months.

<u>Q: If the person has management experience, will it be advantageous for him/her to obtain a visa?</u>

 \rightarrow It is advantageous to have some management or investment experience. However, you will need to prove that experience.

<u>Are there any areas where *it is easier to obtain a business manager visa ?* (For example, <u>differences between Tokyo, Osaka and other regions)</u></u>

 \rightarrow The difficulty of the screening process remains the same. However, the screening period tends to be shorter in rural areas.

<u>If I purchase an existing store (transfer the business), can I obtain a business manager</u> visa?

 \rightarrow If you have financial statements (track record) for the most recent two years and have appropriate sales (approximately 8 million yen or more) and profits, it will be advantageous for the examination of the business management visa.

If I get a business manager visa, can I run a business other than a shop?

 \rightarrow Yes, you can do other business activities. However, it is limited to business activities. They are prohibited from working part-time or being employed at other establishments.

Q: If I obtain a business manager visa, can I open a corporate bank account?

 \rightarrow It depends on the bank, but it is difficult to open an account at a city bank or regional bank. In the first few years, you will likely only be able to set up an internet bank account.

If you need a corporate bank account from the start, you can also acquire a company that already has a corporate account.
